In respect of Media reports on "Upcoming IPOs of two Wholly owned Subsidiaries of Coal India Limited" as appearing in some of the electronic media, it is clarified that "*Activities related to listing of CMPDIL and BCCL, wholly owned subsidiaries of CIL are in progress. Through tendering process, BRLMs have been appointed. DRHP is under preparation and further update will be provided once filing is made in accordance with applicable law.*"

However we cannot comment whether the Material Price movement is due to above news articles or not.
